### **CODE OF CONDUCT**

I, the undersigned athlete that will participate and compete with Boland Tweekamp during the 2020/21 season agree to abide by the code of conduct as outlined below. (Additional or adjustments to the codes may be established by Boland Tweekamp, as the specific competition requires):-

- As an athlete I will comply with all clothing and equipment requirements as determined by Boland Tweekamp regulations.
- As an athlete I will adhere to all established rules laid down by Boland Tweekamp, the organizing committee and the S A Tweekamp Association.
- When competing or representing Boland Tweekamp in a competition I will not use, abuse or be in possession of alcohol or any non-prescription drugs which is strictly prohibited. It is my responsibility to, at all times, be aware of changes made to anti-doping laws.
- As an athlete I will always be in attendance at all team meetings, competition briefings and training sessions which are at the discretion of the Boland Tweekamp Management.
- As an athlete I will follow and adhere to all instructions of the Boland Tweekamp designated managers and chaperones.
- As an athlete I will act and respect the rights of other athletes and their privacy.
- As an athlete I will refrain from any illegal and/or inappropriate behavior that would detract from the “positive” image of Boland Tweekamp; or be detrimental to the SA Tweekamp Association rules and regulations.
- As an athlete I will display proper respect and sportsmanship towards all team members, officials, administrators, organizers, parents and spectators at all times. The decision of the competition official is final unless an appeal is warranted.
- Any additional rulings and or codes of conduct for Boland Tweekamp athletes will be established as needed/required and necessary by Boland Tweekamp Management to effect fitting sportsmanship.
- Failure to comply with this “Code of Conduct” may result in, but not necessarily be limited to, the following actions:-
  - a. the athlete not being permitted to participate in some or all team activities, including competing in the Competition or related activities and/or
  - b. the athlete being sent home (if representing Boland) and in this case, my parents will assume all/full responsibility for my return including any expenses that may be incurred by Boland Tweekamp.
- If I as an athlete have knowledge of any violation of the Boland Tweekamp “Code of Conduct” I have 24 hours to report the violation to the Boland Tweekamp management OR I will be considered as equal partner relative to the violations that has, or will, occur.

Upon notification of any violation of the “Code of Conduct”, a disciplinary committee will be set up which shall promptly investigate the circumstances of the violation(s), and shall notify the athlete(s) involved with the violation(s) of the time and place for a hearing, and shall conduct an informal hearing on the evidence.

The Disciplinary Committee shall then promptly determine the disciplinary action, if any, to be taken.
